## **JEANC BOARD MEETING**

THURSDAY, AUG. 15 from 7-8:30 p.m.

#### I. Call to order

A. President Julia Satterthwaite called the meeting to order at 7:01 p.m.

### II. Introductions

- A. Approve minutes from March 7 meeting
  - 1. Motion: Tripp Robbins
  - 2. Approve: Whitney Huang
  - 3. Vote: 12-0
- B. Approve agenda for this meeting

  - 2. Approve: Brian Wilson

- C. Correspondence from SPLC Director Gary Green
  - 1. Julia shared a July 1 letter from Gary, thanking JEANC for its \$1,050 donation

### III. Old business

- A. Treasurer's report Keri
  - 1. Current balance: \$22,041.18
    - a) Sarah still needs to submit for reimbursement for the JEANC Honor Cord costs from the spring.
    - b) Julie still needs to submit for reimbursement for the award plaques from May.
  - 2. Impact of changes to judge honorarium
    - a) Judging costs went from \$750 last year to \$3,006 this year
    - b) Fitz says he was able to get more judges and the process went smoother for him
    - c) Tracy says judges deserve to paid better and the increased pay honors them and that since judges are getting paid more, we can ask judges for short comments on the entries
    - d) Sarah says the increase is worth it because a higher stipend results in better judges
    - e) Michael says higher pay doesn't necessarily result in better judges unless we really up the pay
    - f) Julie said adding comments is a huge ask based on the number of entries each judge looks at so maybe comments go to award winners only; Julia agrees, especially since we use a spreadsheet to gather judge data
    - g) Sarah said using a platform like Better BNC is expensive but maybe we could partner with other SPAs to help spread out the cost
  - 3. To what extent did our mechanism for getting checks out to JOY, SPLC, Service Above Self and judges honorarium checks work?
    - a) Keri emphasized the importance of using this Request Form when asking her to cut a check to someone
    - b) Fitz asked who should fill out the special JEANC award check request; the general consensus was he should do that

## B. Membership

- 1. Updates to members list Brian
- 2. August Membership Update
  - a) See "Membership Odds & Ends, Goals and (Ongoing) Conversations" on the Membership Update doc for more specifics
  - b) Keri is looking into a subscription-based model for membership instead of a PayPal button which is difficult to create and change
  - c) Tripp says a subscription system could create problems for people whose district/school pays for their membership
  - d) Brian says if go to a subscription system, we want to make sure we don't lose the option for people to have a lifetime membership
  - e) Julia and Sarah commended Brian for his emails to new members.
- 3. Membership boundaries/contest access discussion
  - a) Tripp says we should likely admit anyone based on the bylaws, but the bylaws don't say we have to give them all the benefits of membership
  - b) Sarah says we should come to a board norms decision, so we aren't saying the same thing at a board meetings that we do in Slack, email, etc.; her opinion is that we should have a big tent and let anyone in who wants to join
  - c) Julia asks if anyone has a motion related to this issue or do we want to put that off until the January meeting
  - d) Tracy says any changes would have to happen before next membership year since we've already allowed people outside the geographical area join
  - e) Sarah says we could make a more informed decision about the concern about "poaching" students for contests if we examine the data at the end of the 2024-2025 contest cycle
  - f) Julie says many mentorship and outreach should be a focus of ours
  - g) Michael says he finds the idea of inclusivity a good one, but we should be careful of stepping on JEASoCal toes
  - h) Erin says the requests to join JEANC often come from new advisers who want connection to good advisers, and we have that; perhaps charge more for those outside our geographical area, but we should be open to helping those who want our help
  - i) Tripp says inclusivity is good, but we have a finite amount of time, money and opportunities and we should focus our resources on NorCal people first
  - j) Sarah says if anything, JEASoCal is open to our partnership, and if we help them up their game, that's a good thing
  - k) Paul says a massive invasion from SoCal isn't likely, but if it is, we can revisit the conversation – the overcrowding of the MAC at NorCal Media Day would be one concern in having more members
  - Julia says right now anyone can join and have the benefits of membership, and we will continue with that philosophy, but if anyone disagrees, they can make a motion differently
  - m) Julia asks people to stay engaged on Slack so meetings can move forward in an efficient manner
  - n) Tripp asked that this document be entered into the minutes

- 2. Encourage new candidates to consider joining the JEANC Board either by reaching out to them or giving their name to Julia and she will reach out to them

### E. Annual contest

- 1. Process for selecting strong judges
  - a) Fitz reached out to previous judges who were reliable and had good credentials and asked them to judge the special categories
  - b) If Fitz didn't know the judge, he gave them categories based on their primary preference and vetted them somewhat on LinkedIn, etc.
  - c) Tracy says we should be careful about sending out judging request through social media groups because not every adviser in these groups is a good one
  - d) Sarah says we may want to consider partnering with other SPAs for judging we judge for them, they judge for us
  - e) Susan likes the idea of partnering with other organizations and suggest using members of the San Francisco Press Club as possible judges
- 2. Consider adding election coverage and an arts & entertainment video categories
- 3. Chairs should review the offerings in their categories and suggest any changes by our January meeting


